The Project Plan includes projects identified as part of the BWL's Water Reliability Study, as well as other third-party studies on system optimization, and asset condition, among other things. The Project Plan includes 5 well projects, 16 distribution projects, and 12 water production projects. These projects are proposed to be completed over the next five years as summarized below:

The total estimated cost for all the projects included in the project plan is \$177,675,000. The DWSRF eligible project cost is \$177,675,000. Not all proposed projects may be completed, depending on the needs identified as the fiscal year approaches.

Beneficial impacts of the proposed projects include, but are not limited to, improved system hydraulics by removing water mains with high break counts, elevated levels of tuberculation, elevated roughness, chlorine degradation and have surpassed their useful life. An additional elevated water storage tank will improve hydraulic pressures in the south Lansing portion of the service area during peak demand events and help to reduce the BWL's reliance on backup generators and pumps for water supplies during an emergency. Looping projects would provide redundancy, and reliability in strategic areas. Replacing wells that have surpassed their useful life will increase reliability in raw water production. Improvements at the Dye and Wise Road Water Conditioning Plants will increase reliability, reduce operation and maintenance costs, and optimize the water production process.

The BWL plans to fund the construction of these DWSRF projects through low interest ELGE loans. The predicted monthly cost to a typical residential user in the BWL service area to fund these projects are listed in the table below. It is anticipated that BWL rates will support this.
