## E-Bikes

Limit one rebate per customer. Income eligible rebate applicants must qualify for, and have scheduled an appointment to participate in BWL's Home Energy Visit program or have had the appointment in the last three years. Schedule by calling 800-573-3503. Rebate up to \$1,500 or the purchase price of the bike, whichever is less.

### E-bike requirements

- All three levels of e-bike qualify:
  - Class 1: an electrical assisted bicycle equipped with a motor that aids only when the rider is pedaling and that ceases to provide assistance when the bicycle reaches a speed of 20 m.p.h.
  - Class 2: an electrical assisted bicycle equipped with a motor that aids regardless of whether the rider is pedaling but ceases to provide assistance when the bicycle reaches a speed of 20 m.p.h.
  - Class 3: an electrical assisted bicycle equipped with a motor that aids only when the rider is pedaling and that ceases to provide assistance when the bicycle reaches a speed of 28 m.p.h.
- E-bike must have a minimum one-year manufacturer warranty.
- Battery must be UL 2849 certified.
- E-bike must have two or three wheels and have operable pedals.
- Motor must be 750 watts or less and not powered by gas.
- No kits or adaptations to existing mountain bikes allowed.

### E-Cargo Bike Requirements

- Designed to carry one or more passengers in addition to the rider OR designed to carry heavier or bulkier loads than a traditional bicycle can carry.
- Bike has an extended frame or integrated racking (long tail, long john, Bakfiets or box bike).
- Bike's extended frame has a published cargo load carrying capacity of at least 100 lbs.

## Induction Cooktop

Both standalone cooktops and ranges with built-in induction cooktops are eligible. Rebate is only available for installations in new homes and for replacement of existing natural gas or propane fueled ranges or cooktops. Only valid on purchases of new induction ranges or range cooktops.

### Induction Cooking Requirements

- Induction cooktop must include no less than three elements.
- Cooktop or Range must be at least 24 inches in both length and width.

## Electric Forklifts

Only commercial accounts are eligible for these measures. Limit two forklifts per account.

### Commercial Equipment Requirements

- New items only; no retrofits.
- Must be the first electric forklift purchased by the company OR replacing an existing, fossil fuel powered forklift.
- Forklift lifting capacity must be equal to or greater than 3,000 lbs.

## Electric Lawn Equipment - Residential

Rebate is only available for new mowers; reconditioned mowers are not eligible. Rebate may not exceed purchase price. Corded devices are ineligible for rebate. Dual battery models can count the voltage of both batteries. Batteries must be included in the purchase to be eligible for rebate. Limit one rebate per item per account.

### Residential Equipment Requirements

- Push Lawn Mower – 36V minimum
- String Trimmer – 40V minimum
- Chainsaw – 40V minimum
- Leaf Blower – 40V minimum

### Residential Lawn Equipment Recycling Requirements

- Customers must recycle their equipment prior to applying for this rebate. Proof of recycling must be included with this application.

## Electric Lawn Equipment - Commercial

Commercial accounts only are eligible for these rebates. Rebate is only available for new mowers; reconditioned mowers are not eligible. Rebate may not exceed purchase price. Corded devices are ineligible for rebate. Dual battery models can count the voltage of both batteries. Batteries must be included in the purchase to be eligible for rebate. Limit one rebate per item per account.

### Commercial Equipment Requirements

- Riding Lawn Mower – 50V minimum
- Push Lawn Mower – 36V minimum
- String Trimmer – 40V minimum
- Chainsaw – 800Wh of battery capacity

### Commercial Lawn Equipment Recycling Requirements

- Customers must recycle their equipment prior to applying for this rebate. Proof of recycling must be included with this application.

## Important Information

1. Incomplete applications cannot be processed for payment.
2. Applications must be received within **60 days** of purchase and/or installation of measures.
3. Notification of problems with incomplete applications will be sent via email or U.S. Mail.
4. Applicants will be given **60 calendar days** to respond before application is deemed ineligible.
5. A rebate check will be mailed to you for qualified products. Please allow 4 to 6 weeks to receive your rebate check from the time your application is received by the Hometown Energy Savers® Program.

## Terms and Conditions

This offer is valid only for Lansing Board of Water & Light residential electric customers for a limited time. Offer is good while funds are available and is on a first-come, first-served basis. **Completed documentation needs to be received within 60 days of purchase/installation date.**

Register receipt/invoice will be used to verify purchase date and/or installation of qualified equipment. Products must be new and operational. Refurbished or used products are not eligible for rebates. Rebates not applicable to new construction. Offer redeemable by mail, email or fax.

The Lansing Board of Water & Light reserves the right to withdraw or change this offer without notice. Rebates may not exceed purchase price. Ineligible rebates are subject to denial or repayment to program. The program is not responsible for applications lost, damaged or not received.

**Electric Lawn Tools.** Lansing BWL electric customers need to make a qualifying electric lawn tool purchase to receive the rebate. Any customer seeking the recycled tool rebate for a given tool must recycle an existing gas-powered tool of the same type (e.g., mower) and comply with the following. Drain the gas-powered tool of all fluids and bring it to either:
