- Items purchased meet the qualifying specifications.

Step #2: Attach a copy of your receipts

- Please provide copies of all receipts and/or invoices from product purchases or installations.
- Your receipt or invoice must clearly indicate the equipment type, make, model, price and date of purchase or installation.

Step #3: Get your rebate

- Submit completed application with all required documentation. It is recommended that applications be submitted within 90 days of purchase and/or installation, as funds are limited. Applications received after December 31, 2026 will not be accepted.

E-Bikes - Residential

Limit one rebate per residential account. Income eligible rebate applicants must meet all eligibility requirements of BWL's Home Energy Visit Program and have completed a Home Energy Visit at their home within the last three years. Schedule by calling (800) 573-3503. Rebate up to \$500, not to exceed the purchase price of the E-bike. Visit bwl.com/electrification for more information and measure requirements.

E-bike requirements

- All three levels of e-bike qualify:
 - Class 1: an electrical assisted bicycle equipped with a motor that aids only when the rider is pedaling and that ceases to provide assistance when the bicycle reaches a speed of 20 m.p.h.
 - Class 2: an electrical assisted bicycle equipped with a motor that aids regardless of whether the rider is pedaling but ceases to provide assistance when the bicycle reaches a speed of 20 m.p.h.
 - Class 3: an electrical assisted bicycle equipped with a motor that aids only when the rider is pedaling and that ceases to provide assistance when the bicycle reaches a speed of 28 m.p.h.
- E-bike must have a minimum one-year manufacturer warranty.
- Battery must be UL 2849 certified.
- E-bike must have two or three wheels and have operable pedals.
- Motor must be 750 watts or less and not powered by gas.
- No kits or adaptions to existing mountain bikes allowed.

Appliances - Residential

Rebate is only available for installations in new homes and for replacement of existing natural gas or propane fueled equipment. Only valid on purchases of new equipment. Refurbished, used, or open box equipment are not eligible for rebates.

Induction Cooking Requirements

- Induction cooktop must include no less than three elements. Both Standalone cooktops and ranges with built-in induction cooktops are eligible.

HVAC - Residential

Central ASHP Requirements

- A pre-inspection is required to receive a Central ASHP rebate. Applications received without a pre-inspection code will not be processed. To schedule a pre-inspection, please contact the Hometown Energy Savers program at (800) 573-3503.
- Must replace a gas furnace.
- Must have a SEER2 \geq 15.2, and a HSPF2 \geq 7.8
- Manual J is required and must be submitted with application to receive rebate.

Heat Pump Water Heater

- Must have a coefficient of performance ratio (COP) of 4.5 or higher

Electric Forklifts - Commercial

Only commercial accounts are eligible for these measures. Limit two forklifts per account.

Commercial Equipment Requirements

- New items only; no retrofits.
- Must be the first electric forklift purchased by the company OR replacing an existing, fossil fuel powered forklift.
- Forklift lifting capacity must be equal to or greater than 3,000 lbs.
- Forklift must have either a Lead Acid Battery or Lithium Ion Battery


