Hometown Energy Savers

Pre-Approval Changes

Reminder to check if your project needs pre-approval

Does your project need pre-approval?

Yes, if your project includes:

- Custom measures
- Prescriptive incentives totaling more than \$5,000
- All new construction and major renovation projects that
- have two or more major system replacements (HVAC, lighting, building envelope, controls)



Small Business Program

- No significant changes
- Less than 25,000 sq ft
- > Annual incentive cap is \$5,000
- Reminder: Submit up to date spec sheets. DLC and ENERGY STAR are required!



Indoor Ag Program

New! Energy Recovery Ventilator

- >\$80/ton of cooling
- DLC and ENERGY STAR are required



Other Updates

Compressed Air Application

- > Air leak and repair measure is \$15/hp
- Complete Audit w/Leak Detection and Repair is \$20/hp
- Non-Lighting Application
 - Computer Room AC has changed
 - Submit the complete spec sheet and the operating perimeters for the system with return temps



Lighting Updates

Lighting Application

> Added high-usage lighting with 3 rate tiers

> One shift, min. 1,800 hours = \$0.20/watt reduced

> Two shifts, min. 4,000 hours = \$0.30/watt reduced

> Three shifts, min. 8,000 hours = \$0.60/watt reduced

DLC and ENERGY STAR required



Lighting Updates

> Exterior lighting – **limited time bonus!**

- Standard incentive \$0.30/watt reduced; bonus increases to \$0.45/watt reduced
- > March 1 May 31, 2023 or until funds run out
- Pre-approval required to receive bonus
- > Application must be submitted after March 1 and completed in 90 days
